(FY 1993 Behavioral Health Services - Alcoholism/Rehabilitation  
and After Care Program for Adolescents Components)**

4 **WHEREAS, the Tohono O'Odham Nation is presently operating the**  
5 **Behavioral Health Services - Alcoholism and Rehabilitation and**  
6 **After Care for Adolescents Program Components under FY 1992**  
7 **P. L. 93-638 contract with the Public Health, Indian Health**  
8 **Services; and**

9  
10 **WHEREAS, such tribal operations have been successful and beneficial to the**  
11 **Tohono O'Odham Nation and its people; and**

12  
13 **WHEREAS, 42 CFR 36.205 of the Code of Federal Regulations requires that**  
14 **all proposals to recontract under P. L. 93-638 be submitted to the**  
15 **Tohono O'Odham Legislative Council for approval at least 120**  
16 **days prior to the current contract termination; and**

17  
18 **WHEREAS, the Tohono O'Odham Nation does desire to recontract for**  
19 **provision of services during FY 1993; and**

20  
21 **WHEREAS, the Tohono O'Odham Legislative Council has reviewed and**  
22 **approved the Behavioral Health Services Program-Alcoholism and**  
23 **Rehabilitation and After Care Program for Adolescents (P. L.**  
24 **99-570) program components contract proposal and budgets.**

26 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative**  
27 **Council that it does authorize and request the Public Health,**

6 *Indian Health Services to recontract with the Tohono O'Odham*

8 *provision of services titled: Behavioral Health Services.*

9 **BE IT FURTHER RESOLVED** *that the duration of this recontract extension*  
10 *shall commence on October 01, 1992 through September 30,*  
11 *1993.*


12 **BE IT FURTHER RESOLVED** *by the Tohono O'Odham Legislative Council that*  
13 *the Tohono O'Odham Nation will not fund or operate the*  
14 *program in the interim while negotiations are still being*  
15 *conducted and no executed contract has been awarded by the*  
16 *Indian Health Service, unless the agency authorizes and approves*  
17 *pre-award costs consistent with the Indian Self-Determination Act,*  
18 *as amended and relevant contract regulations.*

19 **BE IT FURTHER RESOLVED** *by the Tohono O'Odham Legislative Council that*  
20 *the Tohono O'Odham Nation's Officials, to wit: the Chairman,*  
21 *Vice Chairman and any designated official are hereby authorized*  
22 *to negotiate and execute the contract, provided however, that any*  
23 *amendments affecting the funding or funding levels of this*  
24 *contract shall be submitted for further prior approval by this*  
25 *Council.*




