Indian Health Service, unless the agency authorizes and approves
pre-award costs consistent with the Indian Self-Determination Act,
as amended and relevant contract regulations.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.
