8 **WHEREAS, such tribal operations have been successful and beneficial to the**
9 **Tohono O'Odham Nation and its people in meeting the needs and**
10 **intent of the EARN initiative; and**

11 **WHEREAS, the Tohono O'Odham Nation does desire to contract for**
12 **continuation of EARN initiatives during fiscal year 1993; and**

14 **WHEREAS, the Tohono O'Odham Legislative Council has reviewed and**
15 **approved the Fiscal Year 1993 Employment Assistance Readiness**
16 **Network grant proposal and budget.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative**
19 **Council that it does hereby authorize and request the Bureau of**
20 **Indian Affairs to contract with the Tohono O'Odham Nation**
21 **under P. L. 93-638 regulations and procedures for the provision**
22 **of services titled: Employment Assistance Readiness Network.**

of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
Tohono O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).*
