WHEREAS, the Tohono O'Odham Nation does desire to recontract for provision of services during FY 1993; and

WHEREAS, the Tohono O'Odham Legislative Council has reviewed and approved the FY 1993 Agriculture Extension contract proposal and budget.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative

Council that it does authorize and request the Bureau of Indian

Affairs to recontract with the Tohono O'Odham Nation under

P. L. 93-638 regulations and procedures for the provision of services titled: Agriculture Extension.

BE IT FURTHER RESOLVED that the duration of this recontract shall

commence on October 01, 1992 through September 30, 1993.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that
the Tohono O'Odham Nation will not fund or operate the
program in the interim while negotiations are still being
conducted and no executed contract has been approved by the
Bureau of Indian Affairs, unless the agency authorizes and
approves pre-award costs consistent with the Indian SelfDetermination Act, as amended and relevant contract regulations.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that
the Tohono O'Odham Nation's Officials, to wit: the Chairman,
Vice Chairman and any designated official are hereby authorized
to negotiate and execute the contract, provided however, that any
amendments affecting the funding or funding levels of the
contract shall be submitted for further prior approval by this
Council.
