

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Waiver of Indirect Cost for FY 1993 Women, Infants and Children)**

3 **WHEREAS, the Tohono O'Odham Nation established a policy to require the**
4 **inclusion of indirect costs in all third party funded agreements;**
5 **and**

7 **WHEREAS, the policy provides for an exception and waiver of the requirement**
8 **by the Tohono O'Odham Legislative Council if it is in the best**
9 **interest of the Nation to do so, that is when the benefits to the**
10 **Nation exceeds the need to collect the revenues from the funding**
11 **agency; and**

13 **WHEREAS, funding from the Inter-Tribal Council of Arizona for the FY 1993**
14 **Women, Infants and Children Program is insufficient to cover**
15 **both direct and indirect cost needs of the program.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative**
18 **Council finds that it is in the best interest of the Nation to waive**
19 **the indirect cost funding requirement for FY 1993 Women,**
20 **Infants and Children Program.**

23 **The foregoing Resolution was passed by the Tohono O'Odham Legislative**
24 **Council on the 4TH day of June, 1992 at a meeting at which a quorum was**
25 **present with a vote of 1,174.0 FOR; 550.0 AGAINST; -0- NOT VOTING;**
26 **and 06 ABSENT, pursuant to the powers vested in the Council by Section 1 (f)**
27 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
