- WHEREAS, the Tohono O'Odham Food Distribution Program has submitted a budget for Fiscal Year 1993 for review and approval by the Tohono O'Odham Legislative Council.
- NOW, THEREFORE, BE IT RESOLVED that the duration of this grant will be from October 01, 1992 through September 30, 1993 unless extended by mutual agreement of both contracting parties.
- BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that
  the Tohono O'odham Nation will not fund or operate the program
  in the interim while negotiations are still being conducted and no
  executed grant has been awarded by the United States Department
  of Agriculture.
