(FY 1993 Food Distribution and Family Nutrition Program)**

3 **WHEREAS, the Tohono O'Odham Nation has operated successfully a program**  
4 **whereby the diet and nutritional needs of eligible Tohono**  
5 **O'Odham have been served by supplementing other federal social**  
6 **service programs; and**

8 **WHEREAS, the funding for the Tohono O'Odham Food Distribution/Family**  
9 **Nutrition Services has been provided through the United States**  
10 **Department of Agriculture; and**

11 **WHEREAS, the continued operation of the Food Distribution Program is**  
12 **essential to provide basic diet and nutrition for eligible clients;**  
13 **and**

15 **WHEREAS, the Tohono O'Odham Food Distribution Program has submitted**  
16 **a budget for Fiscal Year 1993 for review and approval by the**  
17 **Tohono O'Odham Legislative Council.**

19 **NOW, THEREFORE, BE IT RESOLVED that the duration of this grant will be**  
20 **from October 01, 1992 through September 30, 1993 unless**  
21 **extended by mutual agreement of both contracting parties.**



23 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that**  
24 **the Tohono O'odham Nation will not fund or operate the program**  
25 **in the interim while negotiations are still being conducted and no**  
26 **executed grant has been awarded by the United States Department**  
27 **of Agriculture.**

**BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative Council that  
the Tohono O'Odham Nation's Officials, to wit: the Chairman,  
Vice Chairman and any designated official are hereby authorized  
to negotiate and execute the grant, provided however, that any  
amendments affecting the funding or funding levels of the grant  
shall be submitted for further prior approval by this Council.


The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 4TH day of June, 1992 at a meeting at which a quorum was present with a vote of 1,724.0 FOR; -0- AGAINST; -0- NOT VOTING; and 06 ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






