10 **many Tohono O'Odham children; and**

12 **WHEREAS, the Tohono O'Odham Legislative Council is desirous of**
13 **continuing this program for the benefit of its young members.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative**
15 **Council that it does hereby approve the proposed contract for FY**
16 **1993 Title XX - Child Day Care Services.**

18 **BE IT FURTHER RESOLVED that the duration of the contract will be from**
19 **July 01, 1992 through June 30, 1993.**

21 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that**
22 **the Tohono O'Odham Nation's Officials, to wit: the Chairman,**
23 **Vice Chairman and any designated official are hereby authorized**
24 **to negotiate and execute the contract, provided however, that any**
25 **amendments affecting the funding or funding levels of this**
26 **contract shall be submitted for further prior approval by this**




