

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Waiver of Indirect Cost for FY 1993 JTPA Title II-B/Summer Youth
Employment Training Administrative Cost Pool Budget)**

RES. NO. 92-236

**WHEREAS, the Tohono O'Odham Nation established a policy to require the
inclusion of indirect costs in all third party funded agreements;
and**

**WHEREAS, the policy provides for an exception and waiver of the requirement
by the Legislative Council if it is in the best interest of the Nation
to do so, that is when the benefits to the Nation exceeds the need
to collect the revenues from the funding agency; and**


**WHEREAS, funding from the Department of Labor for the FY 1993 JTPA
Title IIB Summer Youth Employment Training Administrative
Cost Pool Budget is insufficient to cover both direct and indirect
cost needs of the program.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative
Council finds that it is in the best interest of the Nation to waive
the indirect cost funding requirement for FY 1993 JTPA Title IIB
Summer Youth Employment Training Administrative Cost Pool
Budget.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative
Council on the 4TH day of June, 1992 at a meeting at which a quorum was
present with a vote of 787.5 FOR; 496.5 AGAINST; 274.0 NOT VOTING;
and 166.0 [07] ABSENT, pursuant to the powers vested in the Council by
Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,
adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




