4 **from concerned members of Chukut Kuk District to recall District**
5 **Chairman, Cecil Williams; and**

6 **WHEREAS, the Election Board submitted the Certification of the Recall Petition to**
7 **the Legislative Council Secretary on June 25, 1992; and**



9 **WHEREAS, the Election Ordinance of the Tohono O'Odham Nation, by Section 13,**
10 **Article X, cites the responsibility of the Tohono O'Odham Legislative**
11 **Council to establish a Special Recall Election dated within 40 days.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative**
14 **Council has hereby established July 25, 1992 to conduct the Special**
15 **Recall Election in Chukut Kuk District of Cecil Williams.**

16 **BE IT FURTHER RESOLVED that the Tohono O'Odham Election Board will be**
17 **responsible to conduct the Special Recall Election.**

19 *The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on*
20 *the 6TH. day of JULY, 1992 at a meeting at which a quorum was present with a vote*
21 *of 1,585.5 FOR; -0- AGAINST; 138.5 NOT VOTING; and 03 ABSENT, pursuant*
22 *to the powers vested in the Council by Section 1 (g) & (l) of Article VI of the*
23 *Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation*
24 *on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian*
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).
