4 **budget; and**


5 **WHEREAS, the Gu Achi District FY-92 budget was \$242,458.84 and it will be**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council**
11 **that it hereby approves the Gu Achi District Council amendment to be**
12 **expended in accordance with the attached budget.**

17 **to the powers vested in the Council by Section 1 (d)(3) of Article VI of the Constitution**
18 **of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January**
19 **18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).






