3 **WHEREAS, Public Law 100-485, the Family Support Act of 1988, was enacted into**
4 **law on October 13, 1988 to revise the AFDC Program to emphasize**
5 **work, child support, and family benefits, to amend Title IV of the**
6 **Social Security Act, to encourage and assist needy children and parents**
7 **under the program to obtain the education, training and employment**
8 **needed to void long term welfare dependence; and**

11 **WHEREAS, the JTPA/JOBS Program submits a revised and further developed**
12 **JOBS Plan for review and approval; and**

13 **WHEREAS, the duration of the JOBS Plan is October 01, 1992 through 1994.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council**
15 **that it does hereby approve the JOB Opportunities Basic Skills Program**
16 **Plan for the period of October 01, 1992 through September 30, 1994.**

18 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the**
19 **Tohono O'Odham Nation's Officials, to wit: the Chairman, Vice-**
20 **Chairman and any designated official are hereby authorized to**
21 **negotiate and execute the JOBS Work Plan for the period of October**
22 **01, 1992 through September 30, 1994.**

25 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on**
26 **the 7TH day of JULY, 1992 at a meeting at which a quorum was present with a vote**
27 **of 1,660.5 FOR; 63.5 AGAINST; -0- NOT VOTING; and 04 ABSENT, pursuant**
28 **to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of**
the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,
1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).


