be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the <u>7TH</u> day of <u>JULY</u>, <u>1992</u> at a meeting at which a quorum was present with a vote of 1,724.0 FOR; -0- AGAINST; -0- NOT VOTING; and 06 ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of 27 the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18. 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
