Council does hereby approve the budget modification to the Community

Education and Information Program and authorizes expenditures in

accordance with the attached budget.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the

Tohono O'Odham Nation's Officials, to wit: the Chairman, Vice

Chairman and any designated official are hereby authorized to

negotiate and execute the contract, provided however, that any

amendments affecting the funding or funding levels of the contract

shall be submitted for further prior approval by this Council.
