4 *Elimination Program under a P. L. 93-638 contract with the Bureau*
5 *of Indian Affairs; and*

6 **WHEREAS,** *the primary purpose of the Probate Backlog Elimination Program is to*
7 *assist districts and individuals in the preparation of family histories,*
8 *inventories and to secure data which would constitute a complete*
9 *probate file for review and submittal to the Administrative Law Judge;*

12 **WHEREAS,** *any amendments affecting the funding or funding levels of the contract*
13 *shall be submitted for review and approval by the Tohono O'Odham*
14 *Legislative Council; and*

16 **NOW, THEREFORE, BE IT RESOLVED** *by the Tohono O'Odham Legislative Council*
17 *that it does hereby approve the amendment to the Probate Elimination*
18 *Backlog Program.*

20 **BE IT FURTHER RESOLVED** *by the Tohono O'Odham Legislative Council that the*
21 *Tohono O'Odham Nation's Officials, to wit: the Chairman, Vice*
22 *Chairman, and any designated official are hereby authorized to*
23 *negotiate and execute the contract, provided however, that any*
24 *amendments affecting the funding or funding levels of the contract*
25 *shall be submitted for further prior approval by this Council.*
