5 **WHEREAS, amendments affecting the funding level or change in the purpose for**
6 **which the funds were budgeted are required to be submitted for review**
7 **and approval by the Tohono O'Odham Legislative Council; and**



9 **WHEREAS, an amendment has been submitted for review and approval.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council**
11 **that it hereby approves this amendment to increase the Soil & Water**
12 **Conservation District budget amount by \$2,415.00 and authorize**
13 **expenditures in accordance with the attached budget.**

15 **BE IT FURTHER RESOLVED that the amount of \$2,415.00 is hereby appropriated**
16 **from the FY '92 General Revenues of the Nation.**

18 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on**
19 **the 10TH day of JULY, 1992 at a meeting at which a quorum was present with a vote**
20 **of 1,357.0 FOR; -0- AGAINST; 367.0 NOT VOTING; and 04 ABSENT,**
21 **pursuant to the powers vested in the Council by Section 1 (d)(3) of Article VI of the**
22 **Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation**
23 **on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian**
24 **Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,**
25 **1934 (48 Stat. 984).**
