4 *Health Services Program under FY 1992 P. L. 93-638 contract with the*  
5 *Public Health, Indian Health Services; and*

7 **WHEREAS,** *the Tohono O'Odham Nation has been notified that funds are available*  
8 *for Health Promotion/Disease Prevention to assist Community Health*  
9 *Representative personnel in Health Promotion and Disease Prevention*  
10 *activities; and*

12 **WHEREAS,** *any amendments affecting the funding levels of the contract shall be*  
13 *submitted for review and approval; and*

14 **WHEREAS,** *an amendment has been submitted for review and approval by the*  
15 *Community Health Services Program for the Health Promotion and*  
16 *Disease Prevention Budget.*

18 **NOW, THEREFORE, BE IT RESOLVED** *by the Tohono O'Odham Legislative Council*  
19 *that it hereby approves and requests Indian Health Services to modify*  
20 *the Community Health Services Contract No. 249-91-0033 to*  
21 *incorporate the attached budget.*

23 **BE IT FURTHER RESOLVED** *by the Tohono O'Odham Legislative Council that the*  
24 *Tohono O'Odham Nation's officials, to wit: the Chairman, Vice*

amendments affecting the funding or funding levels of the contract  
shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 10TH day of JULY, 1992 at a meeting at which a quorum was present with a vote of 1,313.5 FOR; 357.5 AGAINST; 53.0 NOT VOTING; and 03 ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


