

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Citizen Participation Certification - FY-92 DHUD-ICDBG)**

**RES. NO. 92-288**

**WHEREAS, the Tohono O'odham Nation submitted an application for a grant to fund the following eligible Indian Community Development Block Grant Program activities and in connection with such application resolve and make certain assurances:**

*Hickiwan Community Facilities  
Lower Covered Wells Community Facilities  
San Xavier Community Building  
Nolic Community Facilities  
San Simon Community Facilities  
Chui Chu Community Facilities,  
with alternate projects:  
Pisinemo Community Facilities  
Big Fields Community Facilities*

**NOW, THEREFORE, BE IT RESOLVED THAT: Prior to the submission of its application, the governing body of the applicant has:**

- 1. Provided Tribal citizens, especially those living in areas where activities are supposed or ongoing, with adequate information concerning the amount of funds that are available for proposed community development and housing activities, and other important program requirements, and solicited their views and participation.**
- 2. Had at least one adequately publicized meeting at a time and location convenient to tribal Citizens to obtain the views of the**

residents on community development and housing needs.

3. *Developed and published or posted a community development statement in such a manner as to afford affected residents an opportunity to examine its contents and to submit comments.*
4. *Considered any comments or views expressed by Tribal members and has developed the application accordingly.*
5. *Made the application available to Tribal members for review and comment.*

*The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 16th day of July, 1992 at a meeting at which a quorum was present with a vote of 1,149.0 FOR; -0- AGAINST; -0- NOT VOTING; and 233.0 [07] ABSENT, pursuant to the powers vested in the Council by Section 1 (c)(2)(d) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).*
