3 **WHEREAS, the Tohono O'odham Nation is currently operating the Election Board**
4 **with tribal funds; and**

5 **WHEREAS, amendments affecting the funding level or change in the purpose for**
6 **which the funds were budgeted are required to be submitted for review**
7 **and approval by the Tohono O'odham Legislative Council; and**

9 **WHEREAS, an amendment has been submitted for review and approval.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council**
11 **that it hereby approves this amendment to increase the Election Board**
12 **budget amount by \$4,130.00 and authorize expenditures in accordance**
13 **with the attached budget.**

15 **BE IT FURTHER RESOLVED that the amount of \$4,130.00 is hereby appropriated**
16 **from the FY '92 Contingency Fund of the Nation.**

19 *the 16TH day of JULY, 1992 at a meeting at which a quorum was present with a*
20 *vote of 1,610.0 FOR; -0- AGAINST; -0- NOT VOTING; and 114.0 [07]*
21 *ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article*
22 *VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono*
23 *O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant*
24 *Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of*
25 *the Act of June 18, 1934 (48 Stat. 984).*


