WHEREAS, the Legislative Council is concerned for the welfare of the O'odham residing in Mexico and is committed to assisting them in assuring protection of sites in Mexico which are sacred to the O'odham, and facilitating return of human remains, fossils and artifacts of O'odham patrimony; and

9WHEREAS,preservation of O'odham culture is of paramount importance to the10Legislative Council, and the Council supports and encourages11observance of traditional ceremonies by the O'odham and seeks to12facilitate participation in traditional ceremonies whether held in the13United States or in Mexico by all O'odham wishing to take part in15those ceremonies; and

WHEREAS. the Cultural Preservation Committee recommends that a Consultant 17 contract be entered into with Isidoro Asse to run through the end of the 18 Nation's fiscal year, and that the contract be subject to modification to 19 20 extend its term upon agreement of the parties, and that the Consultant 21 will work under the direction of the Cultural Preservation Committee 22 which will work closely with the Vigida officials and keep them fully 23 informed of the Consultant's activities and developments which affect 24 25 them.

NOW, THEREFORE, BE IT RESOLVED THAT:
