4 **WHEREAS,** *the Tohono O'Odham Nation is presently operating the Tohono*
5 *O'Odham Title VII Bilingual Education Program under a five (5)*
6 *year grant with the U.S. Department of Education, Office of*
7 *Bilingual Education and Minority Languages Offices; and*

9 **WHEREAS,** *negotiations were held and the Nation was informed of a*
10 *reduction in funding for the fifth year budget; and*

12 **WHEREAS,** *the Tohono O'Odham Title VII Bilingual Education Program has*
13 *submitted a budget modification to reflect the reduction in*
14 *funding for review and approval by the Tohono O'Odham*
15 *Legislative Council.*

17 **NOW, THEREFORE, BE IT RESOLVED** *by the Tohono O'Odham Legislative*
18 *Council that it does hereby approve the amendment to the Title*
19 *VII Bilingual Education Program grant and authorizes*
20 *expenditures in accordance with the attached budget.*

22 **BE IT FURTHER RESOLVED** *by the Tohono O'Odham Legislative Council*
23 *that the Tohono O'Odham Nation's officials, to wit: the*
24 *Chairman, Vice Chairman and any designated official are hereby*
25 *authorized to negotiate and execute the grant, provided however,*
26 *that any amendments affecting the funding or funding levels of*

Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 4TH. day of AUGUST, 1992 at a meeting at which a quorum was present with a vote of 1,553.5 FOR; -0- AGAINST; 63.5 NOT VOTING; and 107.0 [07] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






