8 **Report which reflects unexpended funds; and**

10 **WHEREAS, any amendments affecting the funding or funding levels of the**
11 **contract shall be submitted for review and approval by the Tohono**
12 **O'Odham Legislative Council; and**

14 **WHEREAS, an amendment has been submitted for review and approval**
15 **reflecting FY 1991 Carryover funds by the Career Center**
16 **Program.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative**
19 **Council does hereby approve the amendment to the Career Center**
20 **Program contract and requests the Bureau of Indian Affairs to**
21 **carryover unexpended funds from FY 91 into FY 92 and**
22 **authorizes expenditures in accordance with the attached budget.**




amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 10TH. day of AUGUST, 1992 at a meeting at which a quorum was present with a vote of 1,660.5 FOR; -0- AGAINST; 63.5 NOT VOTING; and 02 ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




