4 **WHEREAS, the Tohono O'Odham Nation is presently operating the Higher**  
5 **Education Program under FY 1992 P. L. 93-638 contract with the**  
6 **Bureau of Indian Affairs; and**

8 **WHEREAS, the Tohono O'Odham Nation did submit its FY 91 Final Financial**  
9 **Report which reflects unexpended funds; and**

10 **WHEREAS, any amendment affecting the funding or funding levels of the**  
11 **contract shall be submitted for review and approval by the Tohono**  
12 **O'Odham Legislative Council; and**

14 **WHEREAS, an amendment has been submitted for review and approval**  
15 **reflecting FY 1991 Carryover funds by the Higher Education**  
16 **Program.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative**  
19 **Council does hereby approve the amendment to the Higher**  
20 **Education Program contract and requests the Bureau of Indian**  
21 **Affairs to carryover unexpended funds from FY 91 into FY 92**  
22 **and authorizes expenditures in accordance with the attached**  
23 **budget.**






