3 **WHEREAS, the Tohono O'Odham Nation is presently operating the Adult**  
4 **Group Home Program under FY 1992 P. L. 93-638 contract with**  
5 **the Bureau of Indian Affairs; and**

7 **WHEREAS, the Tohono O'Odham Nation did submit its FY 91 Final Financial**  
8 **Report which reflects unexpended funds; and**

9  
10 **WHEREAS, any amendments affecting the funding or funding levels of the**  
11 **contract shall be submitted for review and approval by the Tohono**  
12 **O'Odham Legislative Council; and**

13  
14 **WHEREAS, an amendment has been submitted for review and approval**  
15 **reflecting FY 1991 Carryover funds by the Adult Group Home**  
16 **Program.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative**  
19 **Council does hereby approve the amendment to the Adult Group**  
20 **Home Program contract and requests the Bureau of Indian**  
21 **Affairs to carryover unexpended funds from FY 91 into FY 92**  
22 **and authorizes expenditures in accordance with the attached**  
23 **budget.**

26 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that**  
27 **the Tohono O'Odham Nation's Officials, to wit: the Chairman,**  
28 **Vice Chairman and any designated Official are hereby authorized**





adopted by the Tohono O'odham Nation on January 18, 1986; and approved by  
the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,  
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






