3 **WHEREAS, the Tohono O'Odham Nation did submit an FY-1992 Water**  
4 **Resources Study Re-Contract Proposal in the amount of**  
5 **\$1,772,856.00 to the Bureau of Indian Affairs pursuant to**  
6 **Resolution No. 91-283; and**

9 **WHEREAS, the Bureau of Indian Affairs, Central Office did notify the Nation**  
10 **that funds have been identified in the amount of \$200,000.00 for**  
11 **the Water Resources Study Program for FY 1992; and**

13 **WHEREAS, the Executive Office continues to seek additional funding for the**  
14 **FY 1992 Water Resources Study Program with the Bureau of**  
15 **Indian Affairs; and**

16  
17 **WHEREAS, the Water Resources Study Program does submit for review and**  
18 **approval Budget Modification No. 1 reflecting the amount of**  
19 **\$200,000.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative**  
22 **Council that it does hereby approve the budget modification and**  
23 **authorizes expenditures in accordance with the attached budget.**

25 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council**  
26 **that the Tohono O'Odham Nation's officials, to wit: the**  
27 **Chairman, Vice Chairman and any designated official are hereby**  
28 **authorized to negotiate and execute the contract, provided however,**

that any amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 11TH day of AUGUST, 1992 at a meeting at which a quorum was present with a vote of 1,212.0 FOR; -0- AGAINST; 512.0 NOT VOTING; and 06 ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






