20 **1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation,**
21 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by**
22 **the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**
23 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**






