3 **WHEREAS, on June 26, 1992, the Tohono O'Odham Election Board certified**
4 **a petition seeking the recall of Cecil Williams, Chairman of the**
5 **Chukut Kuk District; and**

7 **WHEREAS, the Tohono O'Odham Legislative Council by Resolution No. 92-**
8 **249 ordered that a special election be held in the Chukut Kuk**
9 **District on July 25, 1992; and**

11 **WHEREAS, a special election was duly held on July 25, 1992; and**

13 **WHEREAS, on July 29, 1992, the Tohono O'Odham Election Board did**
14 **submit its Certification of Election Results that:**

15 **"If less than thirty percent (30%) of the eligible voters**
16 **registered to vote for the office voted in the recall election, or**
17 **if the person against whom a petition is filed received a**
18 **majority of the votes cast, he shall, in either such event,**
19 **continue in office for the remainder of his term"; and, that the**
20 **required number of votes needed to be cast were 211 to meet**
21 **the 30% requirement; and the actual number of votes cast were**
22 **166; and**

26 **WHEREAS, a Contest to the Election Results was filed in accordance with**
27 **Article VIII of the Uniform Election Ordinance; and**

28 **WHEREAS, a hearing was duly conducted by the Tohono O'Odham**

Legislative Council in accordance with the Uniform Election Ordinance; and

WHEREAS, at the conclusion of the hearing, a vote was taken which had the result of certifying the election results.

NOW THEREFORE BE IT RESOLVED BY THE Tohono O'Odham Legislative Council that the results of the special recall election as certified by the Tohono O'Odham Election Board are hereby certified.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 14TH. day of SEPTEMBER, 1992 at a meeting at which a quorum was present with a vote of 764.5 FOR; 729.5 AGAINST; 230.0 NOT VOTING; and 04 ABSENT, pursuant to the powers vested in the Council by Section 1 (g) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






