"If less than thirty percent (30%) of the eligible voters registered to vote for the office voted in the recall election, or if the person against whom a petition is filed received a majority of the votes cast, he shall, in either such event, continue in office for the remainder of his term"; and, that the required number of votes needed to be cast were 211 to meet the 30% requirement; and the actual number of votes cast were 166; and

WHEREAS, a Contest to the Election Results was filed in accordance with

Article VIII of the Uniform Election Ordinance; and

WHEREAS, a hearing was duly conducted by the Tohono O'Odham
