3 **WHEREAS, the Tohono O'Odham Nation has recognized the importance of**  
4 **Head Start Education and stimulation; and**

5 **WHEREAS, the Tohono O'Odham Nation has operated a Head Start Program**  
6 **to provide and serve educational and pre-school learning**  
7 **experiences for children between the ages of 3-5 years of age; and**

8  
9 **WHEREAS, the Department of Health and Human Services, Administration**  
10 **for Children, Youth and Families, has provided funding for the**  
11 **operation of the Head Start Program; and**

12  
13 **WHEREAS, the Administration for Children, Youth and Families will provide**  
14 **funds for the continued operation of the Head Start Program to**  
15 **legal and qualifying applicants; and**

16  
17 **WHEREAS, the Tohono O'Odham Legislative Council has reviewed and**  
18 **approved the Head Start Proposal.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative**  
21 **Council that it does authorize and request the Department of**  
22 **Health and Human Services to contract with the Tohono**  
23 **O'Odham Nation for the provision of services titled: Head Start**  
24 **Program.**

27 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council**  
28 **that the Tohono O'Odham Nation's officials, to wit: the**

5 *however, that any amendments affecting the funding or funding*  
6 *levels of the contract shall be submitted for further prior approval*

10 *The foregoing Resolution was passed by the Tohono O'Odham Legislative*  
11 *Council on the 22ND. day of SEPTEMBER, 1992 at a meeting at which a*  
12 *quorum was present with a vote of 1,597.0 FOR; -0- AGAINST; 127.0 NOT*  
13 *VOTING; and 04 ABSENT, pursuant to the powers vested in the Council by*  
14 *Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,*  
15 *adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by*  
16 *the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,*  
17 *1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).*
