3 **WHEREAS, the Tohono O'Odham Nation has operated successfully an Early**  
4 **Childhood, Headstart and Day Care Program for its young**  
5 **members; and**

7 **WHEREAS, the Department of Economic Security, through a Child Adult**  
8 **Care Food Services Financial Agreement, provides reimbursement**  
9 **of funds for food costs incurred based on the guidelines identified**  
10 **in the agreement; and**

12 **WHEREAS, the Early Childhood, Headstart, Day Care Program submits for**  
13 **review and approval the Child Adult Care Food Program Budget**  
14 **for Fiscal Year 1993.**

15  
16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative**  
17 **Council that it does hereby approve and authorizes expenditures**  
18 **in accordance with the attached budget.**

20 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that**  
21 **the duration of the agreement shall commence on July 01, 1992**  
22 **through September 30, 1993.**



5 *approval by this Council.*



11 *VOTING; and 03 ABSENT, pursuant to the powers vested in the Council by*  
12 *Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,*  
13 *adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by*  
14 *the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,*  
15 *1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).*






