7 **WHEREAS, notification was received from the United States Department of**
8 **Agriculture advising the Tohono O'Odham Nation of an increase**
9 **in funding for purchase of office equipment; and**

11 **WHEREAS, any amendments affecting the funding or funding levels of the**
12 **grant shall be submitted for review and approval by the Tohono**
13 **O'Odham Legislative Council; and**

15 **WHEREAS, an amendment has been submitted for review and approval by the**
16 **Food Distribution Program.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative**
19 **Council does approve the amendment and authorize expenditures**
20 **in accordance with the attached budget submitted by the Food**
21 **Distribution Program.**

23 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council**
24 **that the Chairman, Vice Chairman and any designated official**
25 **are hereby authorized to negotiate and execute the grant, provided**




