4 **WHEREAS, the Tohono O'Odham Legislative Council did address adoption of**
5 **budgets for the Branches of the Tohono O'Odham Nation's**
6 **government at its September General Session; and**

8 **WHEREAS, the Council disapproved the budget submitted for the Legislative**
9 **Branch of the Tohono O'Odham Nation's government; and**

10 **WHEREAS, the proposed Legislative Branch budget in the amount of**
11 **\$849,111., will need to be revised and resubmitted for Council**
12 **consideration; and**

14 **WHEREAS, there is insufficient time to properly formulate and complete a**
15 **new budget proposal for the Legislative Branch; and**

17 **WHEREAS, the current authority of the Legislative Branch to incur costs and**
18 **expend tribal funds will expire at 12:00 midnight, September 30,**
19 **1992; and**

21 **WHEREAS, it would not be in the best interest of the Nation for the**
22 **Legislative Branch to shut down operations due to having no**
23 **approved budget in place.**

25 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative**
26 **Council that the Legislative Branch of the Tohono O'Odham**

*expending funds for its regular operations until a FY 1993 budget
has been adopted.*

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 23RD. day of SEPTEMBER, 1992 at a meeting at which a quorum was present with a vote of 1,588.0 FOR; 53.0 AGAINST; 83.0 NOT VOTING; and 03 ABSENT, pursuant to the powers vested in the Council by Section 1 (d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
