6 **WHEREAS, the LIHEAP Program in the Executive Branch of the Tohono**
7 **O'Odham Nation receives funding through a contract with the**
8 **State of Arizona to pay the Program's operating expenses; and**

9 **WHEREAS, the Program feels that this budget is not adequate to support the**
10 **type and level of services it feels are needed by the Nation; and**

11 **WHEREAS, the LIHEAP Program has submitted a supplementary budget**
12 **(attached hereto and incorporated by reference) for approval by**
13 **the Legislative Council of the Tohono O'Odham Nation, with a**
14 **request for appropriation of funds; and**

15 **WHEREAS, the Committees of Legislative Council having oversight**
16 **responsibility for review of such requests have reviewed the budget**
17 **and appropriation request and recommended their approval and**
18 **adoption.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the**
20 **Tohono O'Odham Nation that it approves the FY 1993**
21 **supplementary budget submitted by the LIHEAP Program, and it**
22 **appropriates funds in the amount of \$3,406.00 from sources**
23 **approved by this Council for support of the FY 1993 budgets.**

BE IT FURTHER RESOLVED that to the extent salaries and wages are to be paid by this budget, payroll taxes in the amount of 10% of salaries are included in this budget, and that employee benefits in the amount of 16% of salaries are to be appropriated separately to the Executive Office budget.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 28TH day of September, 1992 at a meeting at which a quorum was present with a vote of 1,597.0 FOR; -0- AGAINST; 127.0 NOT VOTING; and 10 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
