3 **WHEREAS, the Tohono O'Odham Nation is presently operating the Water**
4 **Resources Program under FY 1992 P. L. 93-638 contract with the**
5 **Bureau of Indian Affairs; and**

7 **WHEREAS, the Bureau of Indian Affairs did initiate the Water Resources**
8 **Technician Training Program which has a strong alcohol and**
9 **substance abuse prevention component to introduce Indian youths**
10 **to the professional field of Water Resources planning,**
11 **development and management; and**

12
13 **WHEREAS, in the second phase of this program the youths are to work with**
14 **their Tribe in the capacity of a trainee for one year; and**

15
16 **WHEREAS, the Bureau of Indian Affairs has informed the Nation of an**
17 **allotment of \$13,000 for the Water Resource Trainee Position; and**

18
19 **WHEREAS, any amendments affecting the funding or funding levels of the**
20 **contract shall be submitted for review and approval by the Tohono**
21 **O'Odham Legislative Council; and**

23 **WHEREAS, an amendment has been submitted for review and approval by the**
24 **Water Resources Study Program.**


25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative**



7 *to negotiate and execute the contract, provided however, that any*
8 *amendments affecting the funding or funding levels of the*
9 *contract shall be submitted for further prior approval by this*
10 *Council.*

13 *The foregoing Resolution was passed by the Tohono O'Odham Legislative*
14 *Council on the 28TH day of September, 1992 at a meeting at which a quorum*
15 *was present with a vote of 1,597.0 FOR; -0- AGAINST; 127.0 NOT*
16 *VOTING; and 10 ABSENT, pursuant to the powers vested in the Council by*
17 *Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation,*
18 *adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by*
19 *the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,*
20 *1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).*
