3 **WHEREAS, the Tohono O'Odham Nation has operated the Tribal Employment**
4 **Rights Office since 1978 and has successfully met the needs of the**
5 **Tohono O'Odham; and**

6 **WHEREAS, funding for the Tohono O'Odham Tribal Employment Rights**
7 **Office has been supplemented by the Equal Employment**
8 **Opportunity Commission; and**

10 **WHEREAS, the continued operation of the Tribal Employment Rights Office**
11 **is essential to eradicate employment discrimination within the**
12 **exterior boundaries of the Tohono O'Odham Nation.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative**
15 **Council that it hereby approves the continued funding for the**
16 **Tribal Employment Rights Office from the Equal Employment**
17 **Opportunity Commission.**

19 **BE IT FURTHER RESOLVED that the duration of this grant shall commence**
20 **on October 01, 1992 through September 30, 1993.**

22 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that**
23 **the Tohono O'Odham Nation's Officials, to wit: the Chairman,**
24 **Vice Chairman and any designated Official are hereby authorized**
25 **to negotiate and execute the grant, provided however, that any**
26 **amendments affecting the funding or funding levels of the grant**
27 **shall be submitted for further prior approval by this Council.**
