4 **Diabetes Prevention Program since November, 1989 through a**  
5 **grant from the Robert Wood Johnson Foundation; and**

7 **WHEREAS, the Tohono O'Odham Nation has established the elimination of**  
8 **diabetes mellitus as a health promotion and disease prevention**  
9 **goal; and**

11 **WHEREAS, any amendments affecting the funding level or change in the**  
12 **purpose for which the funds were budgeted shall be submitted for**  
13 **review and approval by the Tohono O'Odham Legislative Council;**

16 **WHEREAS, the Tohono O'Odham Nation's Health Department did submit a**  
17 **budget modification for review and approval.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative**  
19 **Council that it does hereby approve the budget modification**  
20 **submitted and authorizes expenditures in accordance with the**  
21 **attached budget.**

25 **31, 1992.**

*The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 28TH day of September, 1992 at a meeting at which a quorum was present with a vote of 1,385.0 FOR; -0- AGAINST; 106.0 NOT VOTING; and 233.0 [11] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).*
