

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Hickiwan District to Continue Operations
Pending Approval of FY-93 Budget)

RES. NO. 92-410

WHEREAS, the Hickiwan District Chairman and Vice Chairperson on August 14, 1992 did meet with the Budget & Finance Committee to discuss the FY 1992 and 1993 budget;

WHEREAS, the Budget & Finance Committee did advise the District to request for a continuing resolution on the FY 1992 budget;

WHEREAS, it is in the best interest of the District to continue operations pending the review of the FY-93 budget by the Tohono O'Odham Legislative Council; and

WHEREAS, the continuing resolution would keep the Hickiwan District operating until the FY-93 budget is in place.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it hereby authorizes the Hickiwan District to continue incurring costs and expending funds for its regular operations until the FY-93 budget has been approved and adopted by the Legislative Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 29TH day of September, 1992 at a meeting at which a quorum was present with a vote of 1,610.0 FOR; -0- AGAINST; -0- NOT VOTING; and 114.0 [08] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
