3 **WHEREAS, it is in the best interest of the Pisinemo District to continue**  
4 **operations pending review of its FY 1993 budget by the Tohono**  
5 **O'Odham Legislative Council; and**



7 **WHEREAS, the Pisinemo District Legislative Representatives have certified that**  
8 **funds are available for this interim period; and**

10 **WHEREAS, the Pisinemo District Legislative Representatives have**  
11 **recommended that a continuing resolution be enacted.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative**  
13 **Council hereby authorizes the Pisinemo District to continue to**  
14 **incur costs and to expend funds for its regular operations until a**  
15 **FY 1993 budget is approved by the Tohono O'Odham Legislative**  
16 **Council.**

19 **The foregoing Resolution was passed by the Tohono O'Odham Legislative**  
20 **Council on the 29TH day of September, 1992 at a meeting at which a quorum**  
21 **was present with a vote of 1,610.0 FOR; -0- AGAINST; -0- NOT VOTING;**  
22 **and 114.0 [09] ABSENT, pursuant to the powers vested in the Council by**  
23 **Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation,**  
24 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by**  
25 **the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**  
26 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
