4 **WHEREAS, the Administrator of the U.S. Environmental Protection Agency**  
5 **("EPA") has established an EPA Border Environmental Plan**  
6 **Public Advisory Committee (the "Advisory Committee") pursuant**  
7 **to a Charter, a copy of which is attached hereto; and**

9 **WHEREAS, the Advisory Committee was established to fulfill various**  
10 **objectives, including development of recommendations on EPA's**  
11 **Integrated Environmental Plan for the Mexican-U.S. Border Area**  
12 **(1992-1994) and providing other advice and recommendations to**  
13 **the EPA regarding environmental issues along the Mexican-U.S.**  
14 **border; and**

17 **WHEREAS, the Committee will consist of up to 30 members appointed from**  
18 **constituencies with direct interests in such issues; and**

20 **WHEREAS, one of the member seats is set aside for a representative from an**  
21 **Indian nation; and**

23 **WHEREAS, the Tohono O'odham Nation has been asked by the Offices of**  
24 **Senator McCain and Congressman Kolbe to nominate a person for**  
25 **appointment as a member of the Advisory Committee; and**

27 **WHEREAS, the Nation has substantial and direct interests in environmental**  
28 **matters along the border it shares with Mexico; and**


**WHEREAS, it is in the best interests of the Nation to nominate persons as a

**NOW, THEREFORE, BE IT RESOLVED THAT:**


- 1. The Tohono O'odham Legislative Council hereby nominates  
Alberta Lopez for appointment as a member of the Advisory  
Committee, and further nominates Katherine Norris to serve  
as the Nation's alternate and to attend Committee meetings  
when the member is unable to do so.**
- 2. Josiah Moore, Chairman of the Tohono O'odham Nation is  
hereby authorized and directed to inform the Offices of  
Senator McCain and Congressman Kolbe of the foregoing  
nominations.**

**The foregoing Resolution was presented to the Tohono O'odham Council on the  
29TH day of September, at a meeting at which a quorum was present, and by  
a vote of 511.5 FOR; 973.5 AGAINST; -0- NOT VOTING; AND 239.0 [09]  
ABSENT, failed to pass because it did not receive a majority of the votes cast as  
required by Section 2 of Article V of the Constitution of the Tohono O'odham  
Nation.**
