**WHEREAS, the Legislative Council of the Tohono O'Odham Nation pursuant to Resolution No. 91-543 appropriated funds for the purposes of implementing certain aspects of Resolution No. 91-195 during FY '92 in the total amount of \$72,871.64; and**

**WHEREAS, said amounts were included in Account 920004, and were previously designated for the following purposes:**



*Fiscal Year '93 and shall be available for expenditure until such time as expended.*


**BE IT FURTHER RESOLVED** that these funds shall be used only for the purposes set forth in Resolution No. 91-543 unless the joint Commerce and Budget & Finance Committees shall approve, prior to any expenditure, a change in use, provided that any such change in use must relate to the Nation's bingo or gaming operations.

*The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the 29TH. day of SEPTEMBER, 1992 at a meeting at which a quorum was present, and by a vote of 615.0 FOR; 995.0 AGAINST; -0- NOT VOTING; AND 114.0 [10] ABSENT, failed to pass because it did not receive a majority of the votes cast as required by Section 2 of Article V of the Constitution of the Tohono O'Odham Nation.*
