Tohono O'Odham Nation that it approves the FY 1993 budget
submitted by the Legislative Branch. It is recognized that payroll
taxes for Legislative Branch employees in the amount of 10% of
budgeted salaries are included in this budget. An additional
amount equal to 16% of budgeted salaries is budgeted for
Employee Benefits for Legislative Branch employees as part of the
Executive Branch budget.
