RESOLUTION NO. 92-423

WHEREAS, the 1992 fiscal year ended at midnight on, September 30, 1992
and all spending authority granted under the 1992 budgets ends
at that time; and

WHEREAS, by Resolution No. 92-386, the continued operation of the
Legislative Branch of the Tohono O'Odham Nation was
authorized pending adoption of a operating budget for FY 1993;
and

WHEREAS, the Legislative Branch of the Nation has prepared and presented
a budget that reflects the need of the Branch, said budget is
attached hereto and incorporated by reference.

NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the
Tohono O'Odham Nation that it approves the FY 1993 budget
submitted by the Legislative Branch. It is recognized that payroll
taxes for Legislative Branch employees in the amount of 10% of
budgeted salaries are included in this budget. An additional
amount equal to 16% of budgeted salaries is budgeted for
Employee Benefits for Legislative Branch employees as part of the
Executive Branch budget.




BE IT FURTHER RESOLVED that funds in the amount of \$849,111., are appropriated and authorized to be expended from the sources of funding approved by this Council for support of the FY 1993 budgets of the Tohono O'Odham Nation.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 12TH day of OCTOBER, 1992 at a meeting at which a quorum was present with a vote of 1,157.5 FOR; 187.5 AGAINST; -0- NOT VOTING; and 379.0 [11] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






