## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Recommending Appointment of Ray Austin to Arizona Court of Appeals) RESOLUTION NO. 92-438

WHEREAS, Ray Austin is a Native American who currently serves as an Associate Justice on the Navajo Nation Supreme Court; and

WHEREAS, Justice Austin is an applicant for a position on the Arizona Court of Appeals, Division One, in Phoenix; and

WHEREAS, later this month the State screening committee is expected to recommend three candidates to the Governor for appointment to the position; and

WHEREAS, Justice Austin has demonstrated a strong commitment to the principles of Indian self-government and a thorough command of legal principles in the field of Indian affairs, including the importance of Tribal customs and traditions; and

WHEREAS, justice for Native Americans and Indian Nations in the court system of Arizona would be better served by appointments of Native Americans to Judicial positions within such system who are well-versed in Indian law, familiar with Tribal governments and sensitive to the importance of Native American customs and traditions; and

WHEREAS, the Judiciary Committee and the Chairman of the Nation support the appointment of Justice Austin to the Arizona Court of Appeals.
