- 2. The Chairman of the Nation is authorized and directed to execute the Attorney Contract.
- 3. All fees and expenses payable under the Attorney Contract and which constitute operating costs of Papago Bingo shall be paid from the Papago Bingo Revenue Account, Account No. 920004, and shall be reimbursed by Papago Bingo and credited to such Account; provided that at no time shall the cumulative and unreimbursed payments from the Revenue Account exceed the sum of \$54,692.
- 4. All fees and expenses not subject to payment and reimbursement under the preceding paragraph, and not exceeding the total sum of \$20,000, shall be paid from the Fiscal Year 1993 Operating Budget for the Office of Attorney General.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 17TH. day of NOVEMBER, 1992 at a meeting at which a quorum was present with a vote of 1,382.0 FOR; 127.0 AGAINST; 57.0 NOT VOTING; and 158.0 [8] ABSENT, pursuant to the powers vested in the Council by Section 2 a of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
