11 **WHEREAS,** *the Tohono O'Odham Social Service Department administers this*
12 *home and has submitted a budget under the Developmentally*
13 *Disabled Group Home.*

15 **NOW, THEREFORE, BE IT RESOLVED** *that the Tohono O'Odham Legislative*
16 *Council hereby accepts the fund in the amount of \$6,000., on*
17 *behalf of the Tohono O'Odham Nation.*

19 **BE IT FURTHER RESOLVED** *that said fund shall be used for the Children's*
20 *Home Program/Developmentally Disabled Group Home operated*
21 *by Tohono O'Odham Social Service Department; said*
22 *expenditures are authorized in accordance with the attached*
23 *budget.*
