11 **WHEREAS, the Nation's Tribal State Compact Negotiating Committee has**
12 **recommended amending certain provisions of the Nation's last**
13 **best offer for a compact proposal before it is submitted to the**
14 **court-appointed mediator.**

16 **NOW, THEREFORE, BE IT RESOLVED that Resolution No. 92-461 is**
17 **amended so that the document attached hereto is approved as the**
18 **Nation's last best offer for a tribal-state gaming compact.**

22 **Council on the 11TH, day of DECEMBER, 1992 at a meeting at which a**
23 **quorum was present with a vote of 1,332.0 FOR; 158.0 AGAINST; -0- NOT**
24 **VOTING; and 234.0 [07] ABSENT, pursuant to the powers vested in the**
25 **Council by Section 1 (f) of Article VI of the Constitution of the Tohono**
26 **O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,**
27 **1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
28 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,**
1934 (48 Stat. 984).
