**RESOLUTION NO. 93-004**

**WHEREAS, the leadership of the eleven Districts of the Tohono O'Odham Nation did present a request to the Tohono O'Odham Legislative Council for allocation of P.L. 97-408 funds to all Districts; and**

**WHEREAS, after lengthy and detailed discussion among the District leadership and the Legislative Council, a Task Force was designated to research and review pertinent information in order to develop a plan of funding support to all Districts; and**

**WHEREAS, by Resolution No. 92-440, the Legislative Council did designate the Legislative Budget & Finance Committee; the Executive Office; the Accounting Department; and the District Chairmen's Association as the Task Force; and**

**WHEREAS, the Task Force was charged with presenting their findings on this issue to the Legislative Council at its January 1993 General Session; and**

**WHEREAS, the Task Force did present significant and pertinent information regarding the status of the P. L. 97-408 funds at the January 1993 Session; and**

**WHEREAS, the Task Force recommends that additional time be granted to**

15 update reports to the Tohono O'Odham Legislative Council on

18 The foregoing Resolution was passed by the Tohono O'Odham Legislative

20 Council on the 4TH. day of JANUARY, 1993 at a meeting at which a

22 quorum was present with a vote of 1,481.0 FOR; 53.5 AGAINST; 189.5

24 NOT VOTING; and 04 ABSENT, pursuant to the powers vested in the

26 Council by Section 1 (a), (b), & d(2) of Article VI of the Constitution of the  
27  
28 Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on  
January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the  
Act of June 18, 1934 (48 Stat. 984).
