8 **services continue to be necessary to help alleviate nutritional**
9 **health risks and improve the health of individuals at risk; and**

11 **WHEREAS, any amendments affecting the funding or funding level of the**
12 **Agreement shall be submitted for review and approval by the**
13 **Tohono O'Odham Legislative Council; and**

15 **WHEREAS, an amendment has been submitted for review and approval by**
16 **the Tohono O'Odham Community Health Services; Women,**
17 **Infants and Children (WIC) Program.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham**
20 **Legislative Council that it hereby approves the amendment and**
21 **authorizes expenditures in accordance with the attached budget.**




