**RESOLUTION NO. 93-006**

**WHEREAS, the Tohono O'Odham Nation is presently operating the Tohono  
O'Odham Psychological Services (TOPS) Program under an FY  
1993 P. L. 93-638 contract with Public Health Services, Indian  
Health Services; and**

**WHEREAS, pursuant to Legislative Council Resolution No. 92-381  
authorized the de-obligation of FY 1992 carryover funds and to  
re-obligate these funds into FY 1993 Contracts; and**

**WHEREAS, the Tohono O'Odham Psychological Services has prepared and  
submitted its budget modification to incorporate the re-  
obligated amount for review and approval by the Tohono  
O'Odham Legislative Council.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham  
Legislative Council that it does hereby approve the amendment  
to the Tohono O'Odham Psychological Services budget and  
requests the Indian Health Service to incorporate the said  
budget into the Tohono O'Odham Psychological Services  
Contract No. 249-93-0004.**

11 prior approval by this Council.


12 The foregoing Resolution was passed by the Tohono O'Odham Legislative

17 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,  
18 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
19 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
20 1934 (48 Stat. 984).




