3 **WHEREAS, Public Law 100-485, the Family Support Act of 1988, was**  
4 **enacted into law on October 13, 1988 to revise the AFDC**  
5 **Program to emphasize work, child support, and family benefits,**  
6 **to amend Title IV of the Social Security Act, to encourage and**  
7 **assist needy children and parents under the program to obtain**  
8 **the education, training and employment needed to void long**  
9 **term welfare dependence; and**

12 **WHEREAS, on November 30, 1992 the JOBS Program was notified by the**  
13 **JOBS Federal Representative of FY 1993 partial allocations;**  
14 **and**

16 **WHEREAS, the JOBS Program has submitted a budget for FY 1993 for**  
17 **review and approval.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham**  
20 **Legislative Council that it does hereby approve the FY 1993**  
21 **JOBS Program budget and authorizes expenditures in**  
22 **accordance with the attached budget.**

24 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council**  
25 **that the Tohono O'Odham Nation's officials, to wit: the**  
26 **Chairman, Vice Chairman and any designated official are**  
27 **hereby authorized to negotiate and execute the grant, provided**

4 levels of the grant shall be submitted for further prior approval  
5 by this Council.

8 The foregoing Resolution was passed by the Tohono O'Odham Legislative  
9 Council on the 5TH. day of JANUARY, 1993 at a meeting at which a  
10 quorum was present with a vote of 913.5 FOR; 683.5 AGAINST; 127.0  
11 NOT VOTING; and 04 ABSENT, pursuant to the powers vested in the  
12 Council by Section 1 (f) of Article VI of the Constitution of the Tohono  
13 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,  
14 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
15 1934 (48 Stat. 984).
